Providing Safe Environments for Work, Worship and Study

The United Church has revised its *Workplace Discrimination, Harassment, and Violence Response Policy*, and it is now available for download from the United Church web site. This policy applies to all Communities of Faith, and to the Regional Council and General Council offices. The intent of the policy is to provide safe environments that are free from discrimination, harassment and violence. Return to In-Person Annual Meetings

During the pandemic, the General Council issued a temporary amendment of the Bylaws re Pastoral Relations and Congregational Annual Meetings. This temporary amendment expired as of July 1, 2022. As of that date, Communities of Faith are required to revert to the decision-making polity and procedures prescribed in The Manual, 2022, relating to pastoral Relations and annual meetings. With the peak of the Omicron variant behind us, many of the COVID-19 related public health restrictions and workplace safety measures have been lifted across Canada. Communities of Faith are once again in a
