**Legal Correspondence** re Munro Estate

**Disaster Relief** 

Chantal and Chloe sent out the letter to affected communities. We have received one response back from Hay River asking for any support that we would be willing to provide to support their food program.

Received \$4,542.50 in disaster relief in 2023 plus we had \$13,912 from previous years.

Since we have only received one request, we would like to provide the funds from 2023 to them, and we have the other funds in reserve for those who may make a request in the future.

**Green Grove United** 

In December this came to us with the recommendation that the Executive help them close as they didn't have enough members to fulfill their governance. We may need to create a Commission to go in and help them with closing. The question isn't should they close, it's how to do it well.

Parameters for assisting churches who may need to close

Green Grove is one of many communities of faith who are needing guidance in this process. The Community of Faith Support Committee is aware of this and are looking to the Executive for guidance on how best to have these conversations. There are resources on the website etc. but they looking for maybe some parameters around when they should be having these discussions.

This is a discussion that can possibly be had tri-regionally as the other regions are also having these discussions. Shannon isn't sure if other regions might already have something in place. A big part is thinking about Legacy. Thinking about what their gifts are before their resources wither away to nothing.

# Sedgewick Change of Governance

We received a letter from Sedgewick & St. Andrew's Lougheed. They have been partners for years and would like to formally put everything under one joint pastoral board.

Have they thought about what happens if there is conflict? Splitting later is complicated, so having processes in place in case of conflict is important.

#### **Executive Minister**

Shannon has been busy with personal matters. Working from Ontario currently. Heading to Yellowknife next week.

Correspondence from Office of Vocation regarding a review of the ministry personnel at one of the congregations. There were red flags but it was outside of the review purview. Adam and Shannon are working on whether they will raise those concerns with the congregation. If they are not open to that, we will need to do a review which will give us the authority to go forward.

Rundles Mission is one of our incorporated ministries. We are trying to make it legacy. The board of directors has given his resignation. The property is valuable. We want them to have a plan for the property if the ministry ceases to exist. There may be some work for the Executive to do around Rundle's Mission down the road.

### Pastoral Relations Minister

Pastoral Relations minister report: January 10, 2024

- We continue to have a high need for Pastoral Charge supervisors and Pastoral Relations Liaisons. Currently we need nine (9) Supervisors and at least as many Liaisons.

- I was able to participate in the covenanting service at St. Paul's United Church on January 7th and hope to be present for the covenanting service of Devon/Stoney Plain Communities of faith on January 14th
- On January 9th we had a zoom conversation with the central and western United Churches of Edmonton, hosted by our Growth Animator Jordan Cantwell. It was well attended and I hopeful that it will enable further conversations and possibly some collaboration in the future.
- WE have a wider conversation with a large piece of use to be the Northern Lights Presbytery in planning for the end of January. This too, I hope, will help to develop collaborations and possibly some shared ministry opportunities.
- I am excited about the potential development of a Francophone SME site and possible development of long-standing Francophone ministry near Fahler, AB (within the bounds of lesser slave Pastoral Charge. It is a work in progress, but exciting news.

We will also be working on doing phone calls to some pastoral charges that might be at risk of not voting. We will develop a template/script to help with those conversations. Jim and Helen volunteered to be a part of that conversation.
