Working on statement regarding the police killing of Hoss Lightning, 14 years old. Huge impact on the Sampson Cree Nation and others. Hoping to have this done by the end of the week.

In 2021 the Regional Council passed a proposal from being good relations expressing a huge concern about the Alberta curriculum that was under development at the time. Some work was done in June with an expert in the Red Deer School division that laid out in detail what the concerns are. Hoping to reinvigorate that action.

Transphobic marches that happened across the country last year are starting again this year. The affirming committee might write something from the Regional Council directly to the government and it will come back to the Executive for approval.

Erin, Leanne and Julie have been working on centennial discussions.

OTHER

Jasper United

Both the church and the manse were completely destroyed in the fire.

One of their biggest incomes was their thrift store which is now gone. They would normally get about \$50,000 a year from that.

\$15,000 has been raised for Jasper. \$13,000-14,000 in the emergency fire fund that is available as well. We could also tap into the legacy fund or operational surplus.
