#### **Short reminders of our history for this Centennial year**

Throughout 2025, we'll be featuring very short stories about United Church history. Thanks to historian Gayle Simonson in Edmonton, we can also offer 100-word history vignettes for use in your own community! Here are vignettes 1-8. (Word format; when you click, the file will save automatically to your Downloads folder.) For our fourth vignette, she writes:

**Rev. Astor Schrag,** at the time of church union, was minister at an independent Union Church in Vegreville. In 1925, he attended both the final meeting of the Congregational Union of Canada and the inaugural General Council of the United Church in Toronto. His commitment to church unity never wavered and at age 95, he was still leading an ecumenical Bible study. He died in 1978 at 102. A window in Banff's Rundle United Church, dedicated in 1965, commemorates this Congregational leader in the west.

# ★ American full communion partners file lawsuit on the religious freedom to help migrants and immigrants

February 11 more than two dozen American faith groups filed a lawsuit against the US government for violation of their religious freedom regarding their practices of serving immigrants and immigrant communities. <u>Click here to read it</u>; it's as much sermon as legal language. This push includes our full communion partners, the United Church of

Christ and the Disciples of Christ; most mainline denominations; the Brethren and the Mennonites; the Unitarians; and Reform Jews.

American author and church historian Dr Diana Butler Bass comments, "Remember: Do not obey in advance. Use your freedoms to their fullest extent. Don't give up before we've pushed back. We do not have to surrender. We have rights." We continue in prayer as our US siblings in Christ push back against multiple plans to strip Americans and asylum-seekers of their rights.

# Rescind legislation targeting transgender people: Northern Spirit Executive letter to the AB government

The Regional Executive and the Affirming Committee have written a letter to the premier and relevant ministers calling for immediate rescinding of Bills 26, 27, and 29. These greatly limit transgender, Two Spirit, and gender diverse children and youth's access to appropriate medical care, sports, and correct naming, and greatly reduces all students' access to sexual health education everywhere in Alberta. It is possible that BC

### Action for people and communities of faith on AB bills 26, 27, and 29

This is your invitation to express your concerns about Alberta's Bills 26, 27, and 29 and their impacts on transgender children, youth, and loved ones. Following the lead of the letter from the Executive and the Affirming Committee, you are invited to write or call in your own response as a person of faith and a community of faith. While this legislation will have less immediate impact on our members in NWT and BC, it's possible those travelling to AB for health needs and children's sports will see an impact. And above all, this legislation targets some of the most vulnerable people in Canada. It is a concern for all Canadians.
