<u>Communities of Faith, Community Ministries and Northern Spirit Regional Council Relationships</u> December 17, 2024

Covenantal relationships are ones where two or more people or communities promise to live out a mutually supportive connection and ask God to be within their very fabric. This is the relationship between the Northern Spirit Regional Council (NSRC) (its members, ministries and staff) and each Community of Faith.

In 2025, the Executive would like to know how strong these relationships are from the many points of view – Communities of Faith (COFs), NSRC bodies, Outreach and Community Ministries (CM), clusters, networks etc.

#### JANUARY MEETING:

What is missing here?

What 3 indicators are most important for us nourish (either by continuing, improving or beginning these practices)?

Some of these are drawn from the promises we make to one another as UCC connected folks (requirements from the Manual or NSRC's policies and practices).

1.

NSRC creates opportunities for **connecting** one another with your geographical neighbours for mutual support, sharing of resources and outreach.

COF and CM participate in 1 or more of these opportunities per year.

2.

NSRC **creates** opportunities for like minded people to gather (for example support a Network or Cluster gathering, retreats for worship planning or Ministry Personnel peer support). For example: goal could be that each NSRC Commission and Committee provide one gathering each year, some of which can take place in conjunction with Annual Meeting or other events).

COF and CM leaders (paid and volunteer) **attend** gatherings and events (for example support a Network or Cluster gathering, retreats for worship planning or Ministry Personnel peer support) For example: goal could be that each COF and CM send one person to one gathering each year, some of which can take place in conjunction with Annual Meeting or other events).

3.

NSRC staff and volunteers endeavor to **listen** well and cooperate towards getting the right person/policy/commission/committee to personally connect with COM/CM.

COF and CM leaders **call/email** the NSRC staff and/or Commissions when issues arise needing cooperation such as issues around Property, Pastoral Relations, Social Justice initiatives, governance changes, pastoral care needs or other emergent things)

4.

NSRC staff and/or Commissions **reach out** to each COM and CM once a year, even when there is no specific need or issue arising.

COF and CM leaders **call/email** the NSRC staff and/or Commissions yearly to check in and communicate needs arising and more often to ask specific questions of polity or resources as well as for learning opportunities (like M and P training)

5.

NSRC Executive or Commissions **report annually** (or more) to COF and CMs. COF and CM leadership **review these and report** to appropriate folks in COF and CM.

NSRC volunteers **read Annual Reports** that are submitted and refer/respond to COM/Outreach Ministries and other partners as needed.

COF and CM send in an Annual Report (or more)

6.

NSRC holds **at least one gathering annually** (online or in person) of all members of the Regional Council that includes worship and learning.

COF and CM **send representatives** to that/those meeting(s) who report back relevant information to their communities.

7.

NSRC Commission and staff **respond** to communication re: property or governance changes sought by COF AND CM appropriately and timely manner.

COF and **CM connect with** appropriate NSRC Commission and/or staff about any changes they are seeking to their governance or property in a timely manner.

8.

NSRC will be **responsible with the monies** allocated to them in consultation with COM and CM through their representatives.

COF and CM **pay assessments** allowing staff to do their role, allowing volunteers to be resourced in their roles and so we have funds in emergency savings from NSRC and GC.

9.

NSRC Executive or Commissions will **join** with a COM/CM for worship opportunities to share their passion and work.

COF and CM will **invite** NSRC Executive or Commissions to join them in visioning, long term planning and/or restructuring discussions.
